TERMS:

1. By properly submitting this completed form to the Lindenhurst Chamber of Commerce (LCoC):
 - 1.1. You agree to offer anyone presenting a current Lindenhurst Chamber of Commerce Member Card the goods and/or services you indicated on your submitted Merchant Advertising Request Form until such time as you provide proper notification (as described in the next bullet point) that you are no longer willing or able to offer such goods and/or services.
 - 1.2. The LCoC will post on its website the information on your submitted form that you indicated you want posted. Please refrain from including inappropriate content on your form. The Board of Directors of the LCoC has the final say on what will be posted on its website.
 - 1.3. You agree to immediately notify a sitting member of the LCoC Board of Directors should you no longer be able to or wish to offer the advertised goods and/or services. This will result in the immediate removal of your advertisement from the LCoC website.
 - 1.4. You agree to immediately notify a sitting member of the LCoC Board of Directors should you determine that someone has or has attempted to use a Member Reward card fraudulently or should you determine that someone is presenting a fraudulent card.
 - 1.5. You will receive two (2) 8.5"x11" flyers notifying your customers that you are participating in this program and where they can learn more about the LCoC.
 - 1.6. You agree to consider posting the provided Member Rewards Card Program flyer somewhere appropriate within or around your premises. Posting a notice of any kind is not a requirement to participate in this program. You may create and post an alternative notice though we ask that you submit it to a sitting member of the LCoC Board of Directors for review and allow the LCoC to consider adopting your design for use at other merchants if they choose.
2. Member cards are good within the issued calendar year as indicated on the front of each card. Participating merchants are only obliged to provide their advertised offers to customers that produce a current Member card.
